R-3 Zoning District-Rt390

Also, in attendance were Janine & Trevor Sopko who reside within the proposed zoning district change. Motion: Romagnolo moved and seconded by Poles to recommend approval to the Board of Supervisors conditioned upon revising the definition of VEHICLE REPAIR SHOP, LIMITED RESIDENTIAL to include that the facility be ancillary to a single-family detached dwelling.
